GREYSTONE VILLAGE HOA BOARD

There have been two meetings of the Greystone Village Homeowners Association Board since our last newsletter. The dates were July 16 and September 17.

The Recreation Committee reported that we should finish the year under budget, and that we had no major accidents or injuries. Membership renewals were stronger this year than last year, but there was an unanticipated \$17,000 expense. The drains in both pools had to be replaced in compliance with the Virginia Graeme Baker Act. The Board approved the request by Alacia Bilow, President of the Swim Team Board, to join the Recreation Committee.

Lakes and Grounds discussed several issues. Baker's Lake did not have to be sprayed for hydrilla, and it will be dredged before the end of the year. Guins, which dredged Winchester Lake, submitted the most reasonable bid and will do the work. Abandoned boats around Baker's Lake have been tagged to be removed soon.

The City has agreed to bring the Greystone dam up to code by repairing it and raising its height.

Since they will need to lower the lake level to accomplish that, the Board decided to wait to dredge Greystone Lake at the same time. The City hopes to have its bids in place and to begin the work in early 2010.

Options for replacing the gazebo at Winchester were discussed and the Board will wait for feedback from the neighborhood before proceeding further. In addition, various ideas are being considered for landscaping and maintenance around the neighborhood signs.

Kelly Ybarra, the director of the new Greystone Recreation Center, shared plans and programs with the Board. The Citizens Area Liaison hopes to work with the Parks Dept. to use the new center for meetings. (See also on Page 2.)

The Greystone Village Board of Directors meets every two months, on the third Thursday of the month at Coldwell Banker Advantage, 6008 Creedmoor Road. Homeowners are welcome to attend. TIME IS RUNNING OUT . . .

for the \$8000* TAX CREDIT FOR FIRST-TIME HOMEBUYERS!

You have probably heard of this terrific program, but are you aware that to take advantage of it you **must close on a property by November 30, 2009**? Since it usually takes about 4 to 5 weeks to settle a home once a purchase contract is written, there is not much "shopping time" left. (In reality, one should try to close as soon as possible in order to avoid a last-minute rush that might delay your closing beyond the deadline.)

Some basics of the program are noted below.

Qualifying: To qualify as a "first-time homebuyer" the purchaser or spouse may not have owned a residence during the three years prior to the purchase. (To clarify, "purchase" refers to the closing of the house; not the signing of a contract.) In addition, the home must be purchased between Jan. 1, 2009 and November 30, 2009.

Properties: The 2009 tax credit may be applied ONLY to primary residences, including single-family homes, condos, townhomes, and co-ops.

How much?: The maximum allowable credit is \$8000*. Each buyer's tax credit is determined by two factors: (see page 2)

RECYCLING TIPS

The June newsletter noted which items the City of Raleigh encourages us to recycle. As a follow-up, this newsletter tells us **how to prepare** items which are placed in the green Raleigh Recycling bin and which items should **not be recycled**. The City has requested observance of the guidelines listed below.

- Rinse and crush cartons and plastics to conserve space.
- While plastic lids or caps can be left on emptied plastic bottles, any metal caps or rings should be removed. (Hint: crushing the bottle and then putting the plastic lid back on will help keep the bottle flattened.)
- Check your plastic containers to be sure they are bottles. A bottle is defined as having a base that is larger than its "neck." Bottles also normally have a screw-on lid.
- Do not recycle any plastic bottle that previously contained hazardous material that may come in contact with Solid Waste Services workers, potentially causing harm. Included would be motor oil, brake fluids, pesticides and anything with the poison symbol on it.
- Rinse and remove any plastic or metal tops from glass containers.
- Do not put any broken glass in the recycling bins.
- Glass food and beverage containers are the only glass products the City collects for recycling.
- Plate or window glass, light bulbs, mirrors, dishes, glassware and ceramic materials cannot be recycled through the City's program.
- Remove newspapers, inserts, magazines and catalogs from plastic bags, envelopes or coverings.
- Stack newspapers, inserts, magazines, catalogs and white paper neatly and place on TOP of all other materials. (Please fasten the tie straps over these materials to avoid littering.)
- Only white paper (either blank or with color printing) is accepted, including envelopes with windows. No colored paper, check books, carbon paper, books, paper with adhesive backing or paper bags may be recycled.
- No unopened mail, as it may contain items such as colored paper, promotional stickers or product samples, which could contaminate the entire batch of paper collected.

REMINDER: The new state law banning plastic bottles from trash cans begins **OCTOBER 1, 2009**.

(1) the price of the home, and (2) the buyer's income. The credit is equal to 10% of the purchase price of the home, up to \$8000. Single buyers with incomes up to \$75,000, and married couples with incomes up to \$150,000, may receive the maximum credit. The tax credit is reduced proportionately for singles earning between \$75,000 and \$95,000, at which point the credit would be zero. For couples, the phase-out income would be \$170,000.

Repaid?: No (unlike the 2008 tax credit). However, if the property is sold within 3 years, the credit will be recaptured.

Fall Reminder
